What: The scholarship covers the cost of tuition, books, and fees for full or part-time students enrolled in a degree or certificate program, or for students who wish to take courses for personal enrichment.

When: The deadline to apply is July 15 for the fall semester, December 15 for the spring, Late applications will be accepted if funds are still available.

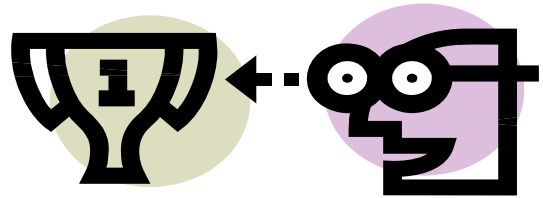
