Policy Project Update:

Dr. Weinacker provided a summary of the policy project and demonstrated policy stat along with the new template to be used on all policies. The new format will be more efficient and will allow easier updating of policies for public viewing. All employees will have access to policy searching database while students will not, however the general public can view a policy in policy stat via the current policies webpage.

Policies will have new URLs, links to policies on other departmental webpages will need to be updated. Dr. Weinacker will reach out to Web Services to see if there is an easier way to do this.

In discussion with consultants it was decided the process of policy making was too cumbersome. Moving forward a JotForm will be sent out campus wide to receive input from everyone in regards to policy changes, sunsets, or new policies.

• Participatory Governance Update:

Policy Review Committee will align with College Council and shared governance. Policy committee will make new recommendations on policies and send them to College Council.

• **Draft Charter** (attached)

Policy Review Committee discussed a draft of their charter. Policy committee will keep current members, having two members from each division to maximize input. Discussion took place on what constitutes a quorum in the new policy charter.

It was recommended that a simple majority would constitute a quorum and enough votes to move a policy forward. Committee members may designate alternate representatives to serve in their absence.

Policy meetings will continue to meet on the final Thursday of each month and will receive the agenda on the Monday prior to the meeting. For now, the PRC membership will continue to reflect the charter.
