## Policy Sunset: 3.13 – Internships and Service Learning

#### **Committee Action:**

Policy discussions began at meeting on January 25th 2022 and continued today

Committee discussed guidelines in student catalog that meet HLC requirement for written agreements for managing internships and clinical placements in the institutions program.

It is recommended to use the student catalog for the purpose of internship guidelines.

Committee recommends sunsetting the policy as of the end of the day on June 30<sup>th</sup>, 2022, the final day of the fiscal year.

Policy 3.13 is currently referenced in 2021-2022 Student Catalog. Reference will be removed in the 2022-2023 Student Catalog.

Stacy Hilton will update the 2022-2023 Student Catalog to ensure HLC student internship requirements are met.

Committee agrees by consensus to sunset policy 3.13 as of June 30<sup>th</sup>, 2022, The final day of the fiscal year.
