2. Call to Order – PROCEDURAL

Chairman Sigafoos called the Yavapai College District Governing Board meeting to order at 1:00 p.m.

From the Town of Clarkdale, Councilman Bill Regner. From the City of Cottonwood Mayor Tim Elinski and Councilmember Tosca Henry. From the Yavapai Apache Nation Jane Russell Winiecki. From the City of Sedona, Mayor Sandy Moriarty, Councilman Scott Jablow and Councilmember Jessica Williamson. Chair Sigafoos welcomed all guests and staff.

11. Open Call - Procedural

Bob Oliphant – Discussed an analysis for the Southwest Wine Center and recommended a solar farm. Ruth Wicks – Discussed secondary outreach with Manzanita Outreach, ending hunger with the Verde Valley Collaboration and addressed concerns regarding buildings being built in the Verde Valley Joe Butner – Requested that the Board consider collaborating with Camp Verde Schools for vocational education – specializing in an Equine and Agricultural technical education program.

Tim Elinski – Discussed the importance of trade programs for the Verde Valley and discussed the shortage and crisis situation for needs regarding trades.

Karen Strauch - Spoke on behalf of trade and CTEC program for the Verde Valley. The Verde is still waiting on more equitable distribution of funds. The Verde Valley needs technical programs.

Ernie Strauch – Discussed the importance of a CTEC center in the Verde Valley. Promises were made to emphasize needs in the Verde Valley and feels the promises were largely unfulfilled.

Carol German – Requested the Board to consider centralization in programming for the Verde Valley Academy with the budget.

Scott Jablow – Discussed the importance and value in trade programs. Prescott has had Career Tech Institute and shared the importance and need of trade classes.

Sandy Moriarty – Shared, on behalf of the City of Sedona, to encourage a technical career facility for the Verde Valley.

Jessica Williamson – Requested the Board find a way for the Verde Valley to have Economic Development and CTEC.

Jane Winiecki – Welcomed the Board and President. Shared about the possibilities of Yavapai College and would like the Verde Valley Campus to be vibrant again.

Barbie Duncan – Welcomed the Board and President Dr. Rhine. The Community is here to support Yavapai College and thanked the Board for choosing Dr. Rhine's Leadership.

Bill Regner – Shared the need for CTEC and efforts in designing building L. The Verde Valley needs a centralized and comprehensive CTE facility and program.

Judy Culver - Provided details regarding the Blowout Wash Trail System.

Richard Dahl – Shared and cited the critical need for a career and technical education and workforce development.

Helaine Kurot – Shared the need for CTEC to bring more programs to the Verde Valley.

Dr. Lisa Rhine presented on Years of Service Recognition and the Board of Supervisors meeting. Dr. Perey, Executive Dean and Campus Executive Officer for the Verde Valley Campus provided updates on the progress of Building L and the Trail System. Dr. Perey shared details on Economic Development and Career Technical Education (CTE). Career Technical Education needs to identification in terms of the types of education. Member McCasland stated that we need more CTE and the Verde Valley is prime and ready for the residents of the Verde Valley for capital improvements.

Dr. Liss and Selena Bliss on behalf of Matt Pearcy shared, that faculty currently has a workgroup that is looking to have workable solutions regarding committees. A Standards Committee has recommended faculty to conduct a trial Open Education Resources OER to help catalog. Looking forward to the evening of recognition. Member McCarver asked about the dates.

Members of the Student Leadership Council Matthew Crocker, Holly Mainheart and Carissa Bond, provided details on School of Career and Technical Education, Lifelong Learning, Office of Instructional Support, Student Development, and shared their experience of the decision to return to school and attend a nursing program.

22. Consideration of the Preliminary Budget FY 2019-2020 – INFORMATION AND/OR DISCUSSION

Dr. Ewell provided the Yavapai College Preliminary Budget including: the General Fund by NACUBO Function, General Fund Expenditures including, Public Service, Scholarships, Physical Plant Op/Maintenance, Student Services, Institutional Support/Admin, Academic Support; Instruction; Tuition and Contingency and the Capital Improvement Plan.

Member Chevalier shared concerns about a year delay for the Verde Valley Capital Budget; Member McCarver shared the need for CTEC now and is in full support of renovating L and looking at other locations for CTEC. Proceed with the project assessing how to identify the trades that are necessary that benefit the Verde Valley. Member Chevalier asked for a commitment to have a plan begin for trades that work well in Prescott that could potentially work in the Verde. Member McCasland requested handouts to be available for PowerPoint presentations.

Member Irwin asked Board Attorney Adams about scenarios regarding what is allowable for the President without the approval of the Board. Board Attorney Lynne Adams stated it would have be for College related purposes.

Member McCarver moved, seconded by Member Chevalier, to approve the Executive Limitation 2.5 policy and its sub policies. Motion carried unanimously. (Chevalier, Irwin, McCarver, McCasland, Sigafoos voting in favor).

Member Irwin moved seconded by Member McCarver, to approve the 2.6 Board Members Code of Ethics and its sub policies. Motion carried unanimously. (Chevalier, Irwin, McCarver, McCasland, Sigafoos voting in favor).

Member Chevalier shared that the policy is limited as written and needs to be expanded regarding policy 3.4.3. Member McCasland stated the Board needs to have more input regarding 3.4.2.2.
