Charter: Strategic Planning Steering Committee

Purpose:

As part of a shared governance structure, the Yavapai College Strategic Planning Steering Committee is responsible for the following:

- Understanding the components of an institutional strategic plan and developing those that are necessary (i.e., Vision, Mission, Values Statement, etc.)
- Being aware of strategic issues in the internal or external environment related to the institutional planning process and ensure that the Committee is informed
- Actively participating in committee activities and discussions
- Engaging identified stakeholder groups in the development of the objectives and goals for the institutional strategic plan, and providing feedback to those groups on a continuing basis, through a variety of forums
- Developing and supporting the objectives and goals of the institutional strategic plan
- Identifying or developing key indicators and assessment measures to document implementation of the Strategic Plan objectives and goals and reviewing those indicators and measures on an annual basis (or charging another committee to do so)
- Promoting and advocating for implementation of the institution's Strategic Plan to all internal and external stakeholders
- Actively engage in disseminating information about the planning process, the Strategic Plan, and its implementation

The Committee will develop a plan that is presented to the President. This role does not include the final selection of strategic initiatives or actions.

- Review of the recent PACE Campus Climate Survey
- Review of the most recent Ruffalo Noel Levitz Student Surveys
- Review of the Mission, Vision, and Values Statements
- Data Summits to disseminate and share important planning information with stakeholders:
 - College Staff and Faculty (District Wide)
 - District Governing Board
 - o Community Leaders (Business, City & Towns, K-12, Non-Profit)
 - Community Members
- Open forums and online survey to obtain stakeholder input and feedback
- Development and oversight of all appropriate planning documents (Mission, Vision, and Values Statements, Strategic Plan, and ultimately the Implementation Plan)
- Review and alignment of the strategies that currently or will govern the institution, including but not limited to the following:
 - Academic Master Plan
 - Facilities Master Plan
 - o Strategic Enrollment Management Plan
 - o ITS Technology Plan
- Develop a 3-year integrated rolling Strategic Plan
