Veterans Education & Transition Services Semester Benefits Checklist: Summer / Fall 2024

Activate Your VA Education Benefits This Semester

Before registering for classes, meet with your academic advisor to create an education plan to reach your goals. VA education benefits can only be used for classes that fulfill requirements on an approved degree or certificate. To schedule an advising appointment, call 928-776-2106 or 928-634-6510, or visit www.yc.edu/advising. Following your plan is the most efficient way to graduate on time and will ensure smooth processing of your VA education benefits. When you have your education plan, follow these simple steps to activate your benefits:

Step 1 - Register early. Log in at www.yc.edu to search and register for classes. **Summer** registration begins **Mon 4/8/24** online at 7am; offices open at 8am. **Fall** registration begins **Mon 4/15/24** online at 7am; offices open at 8am.

Step 2 - Submit your Semester Benefits Request. This will prompt our office to review your class schedule and certify your eligible coursework to the VA.



Log in at <u>www.yc.edu</u> > open the "V.E.T. Services" menu > click "Semester Benefits Request." Then check your YC email regularly.

Submit a new request at the time of registration each term, and again any time you change your class schedule.

Step 3 - Sign up for the Veterans Payment Plan. This will serve as your agreement to pay, prevents your classes from being dropped for nonpayment, and allows time for your benefits to be processed before payment is due. See next page for more important info about this special payment plan. Students using Ch. 31 benefits or with financial aid (Pell grant, etc.) in excess of tuition charges are exempt.

llow these click-by-click instructions one time for each term (once for summer, once for fall):
☐ Log in at www.yc.edu (user name / password required). Open the "V.E.T. Services" tile.
☐ Click the "Veterans Payment Plan" link. This will open CashNet.
$\hfill\Box$ Click "View Payment Plan Options" and follow the prompts. Read all on-screen information.

- Step 4 Verify your continued enrollment each month to ensure timely payments. If your benefit type requires monthly enrollment verification (this currently excludes only Ch.31 VRE recipients): verification of your continued enrollment is required each month for payment. Failure to verify your continued enrollment for two consecutive months may result in VA withholding your benefit payments until you verify. Verification methods vary by benefit type:
 - Ch. 33: You are strongly encouraged to sign up for text message verification. Call VA to be sure they have your correct mobile number, or to verify by phone: 1-888-442-4551.
 - Ch. 30 and 1606: Complete your verification via the Web Automated Verification of Enrollment (WAVE) system at https://gibill.va.gov/wave, or verify by phone at 1-877-823-2378.
 - Ch. 35: Chapter 35 students need to verify enrollment only if pursuing a certificate rather than a degree as their primary program. Verify by phone at 1-888-442-4551.

Understanding the Veterans Payment Plan

The **Veterans Automated Payment Plan** is your agreement to pay Yavapai College for your tuition and fees by the established deadline (see below), *regardless of what may happen with your VA education benefits*. Available only to students using VA education benefits, this payment plan allows your classes to be held and your benefits to be processed before payment is due to the college, as long as you get the three steps shown above done early.

If you already have a non-VA financial aid award, the system may not give you the option to use this payment plan; this is typically because your financial aid award is sufficient to cover your tuition and fees, and therefore your financial aid award acts as your promise to pay. If you have questions, please call us at (928) 717-7613.

There is <u>no down payment or set-up fee</u> for this plan, but you will need to provide credit/debit card information as part of the set-up process. During certain dates each term, you may include textbook charges at the Yavapai College Bookstore in your Veterans Payment Plan for convenience; **bookstore expenses charged to this plan will be added to your balance due on the payment deadline.**

Review your YC account in advance to avoid surprises on these dates. If you still owe a balance on the payment deadline, that amount will be drafted from the account you used during set-up. The payment deadline cannot be changed for any reason, so it is important to submit your Benefits Request early, and to apply for financial aid at www.fafsa.gov to ensure adequate financial resources. A \$25.00 late fee is charged for a missed or declined payment. How the Plan Works with Your Benefit

<u>Chapter 33 Post-9/11 GI Bill®</u>: Because this benefit pays tuition and fees directly to the school, you may only have a balance due if one or more of the following applies: you are eligible at less than 100%; you take classes that are not applicable to your approved program; you charge textbooks to your Veterans Payment Plan; or you apply too late for benefits to be paid before the balance due date.

<u>Chapter 31 VA Veteran Readiness & Employment (VRE)</u>: The Veterans Payment Plan is <u>not</u> needed if your benefit eligibility is established prior to registering. Contact your VRE Counselor to be sure your coursework has been authorized for payment before you register.

<u>All Other Chapters</u>: You are encouraged to make early payments in order to lower the total balance due on the deadline date. Contact the Cashier at (928) 776-2124 or jami.dodwell@yc.edu; visit www.yc.edu/bills for info.
