# II. Approval of Minutes

A) Strategic Task Force recommendations

Michael presented the recommendations of the strategic task force. They are:

He then presented recommendations for realizing the vision and mission statements, as follows:

Short term goals:

We recommend the creation of a **Volunteer Committee**. Its charter is "To create and support additional opportunities for members to participate, engage, and contribute to OLLI."

Examples we believe that belong as subgroups of the Volunteer Committee could include (but are not limited to)

Social Connections
Tech Assistants
Zoom Tech Assistants
Classroom Hosts
OLLI Trolley Drivers

Retain and engage members through a variety of efforts to keep 75% of our current members active.

We challenge our existing committees to find a role in retaining and engaging our members during these online times and beyond.

Curriculum committee – find facilitators willing to deliver content online Technology committee – finding ways to help train facilitators deliver online content, finding ways to help train our members to receive online content

Social Connections – task force, helping organize our online connections, call trees.

A motion to adopt the vision and mission statements was made, seconded and approved.

A separate motion to adopt the volunteer committee and to engage members of OLLI through the mechanisms stated was made, seconded, and approved.

It was noted that John Lowe had resigned from the Curriculum Committee and that his resignation had been accepted. It was also noted that Sandra Bennett had resigned as chair of policy and procedures.

Tricia presented a comprehensive worksheet showing OLLI finances to date and projected for the year. The worksheet had been circulated to all GC members. It showed OLLI to be a little short of budget this year, but not much. She warned that there would probably be a dip in income in the spring of 2020 as people whose membership was extended this year would not be renewing at the same time next spring, but would have a two month additional membership.
