## **THE FAST TRACK PRACTICAL NURSING PROGRAM PHILOSOPHY**

The practical nursing faculty share the mission and values of Yavapai College. We are committed to contributing to the profession of nursing through teaching and service. We recognize that practical nursing students are unique, come from diverse backgrounds, and have individual learning needs. We believe that nursing is an art and science and that a sound practical nursing education curriculum integrates knowledge from the sciences and the humanities.

## **PRACTICAL NURSING**

Practical Nurses (PNs), regardless of specialty or work setting, treat patients, educate patients and the public about various medical conditions, and provide advice and emotional support to patients' family members. PNs record patients' medical histories and symptoms, help perform diagnostic tests and report results, operate medical machinery, administer treatment and medications, and help with patient follow-up and rehabilitation.

## **EMPLOYMENT OUTLOOK**

According to the Bureau of Labor Statistics (2022) at the U.S. Department of Labor, Licensed Practical Nurses (LPNs) will continue to be in demand, and job opportunities are expected to be favorable. There is a need to attract and retain qualified workers to replace those who will transfer to different occupations or retire over the coming decade. Employment of LPNS is projected to grow 6% from 2021 to 2031, about as fast as the average for all occupations. Growth will occur for numerous reasons, including an increased emphasis on preventive care; growing rates of chronic conditions, such as diabetes and obesity; more admission to long-term care facilities, and greater need for home healthcare. In addition, because many older people prefer to be treated at home or in residential care facilities, LPNs will be in demand in those settings.

Students often receive offers for employment from the same health care organizations where they completed their clinical rotations. In Arizona, the national median salary for LPNs is \$59,336, which is above the national medical average of \$48,031 (Lightcast, 2022).

## **PROGRAM DESCRIPTION**

The Certificate of Completion in the Yavapai College Fast Track Practical Nursing program provides students with the theory and skills required to practice as a practical nurse in acute care, extended care, and intermediate care settings. The program of study combines nursing theory lectures with clinical experiences in a variety of patient care settings including hospitals, nursing homes and other healthcare agencies. Graduates are eligible to take the National Council Licensure Examination (NCLEX-PN) to become a licensed practical nurse (LPN). Licensing requirements are the exclusive responsibility of the Arizona State Board of Nursing.

The Fast Track Practical Nursing program is a 2 sequential semester (excluding summer) program that prepares students for entry-level positions as practical nurses. The program starts twice per year: in the Fall and Spring semesters.

Prior to program application, the applicant must have an active Arizona certification or licensure as a CNA or LNA, or MMP, with one year of full-time or two years of part-time recent (within the last 5-years) work experience; and a successful score on ATI TEAS entrance exam (proficiency in Reading, Math, Science, English and Language). High school diploma or GED is required. Applicants must be 18 years of age by program start.

## **LOCATIONS**

The lecture, skills lab and simulations component of practical nursing classes are taught on campus. Students will need a computer with reliable Internet access, a web camera, and a microphone. All students are required to provide their own transportation to off-campus clinical activities.

The curriculum is designed in accordance with the standards set forth by the Arizona State Board of Nursing. The program is designed around a model of classroom and laboratory instruction integrated with hands-on experience in a clinical setting that provides a thorough educational foundation and professional preparation to enter the workforce as an independent practitioner upon graduation.

The Fast Track Practical Nursing Program is rigorous and involves a **full-time** commitment of 40 hours or more per week. In addition to classroom presentations, there are activities in campus nursing labs, clinical agencies, and discussion groups. Homework, multimedia, and out-of-class assignments are also required. Students must maintain a minimum grade of 78% in all practical nursing courses to remain in the program. Students must be prepared to meet the challenge and establish priorities prior to the start of classes.

Graduates of the program are eligible to:

1. Receive a Fast Track Practical Nursing program certificate of completion.
2. Sit for the National Council Licensure Examination for Practical Nurses (NCLEX-PN)
3. Apply for licensure to practice nursing (Licensed Practical Nurse)

## **LICENSURE**

Graduation from the Yavapai College Fast Track Practical Nursing program is not the sole criteria for obtaining a license to practice nursing in Arizona. Licensing requirements are the exclusive responsibility of the Arizona State Board of Nursing (Nursing Practice Act A.R.S. Sections 32-1632, et seq.), and students must satisfy those requirements independently of their satisfaction of any requirements for graduation from Yavapai College.

The Arizona State Board of Nursing will deny licensure if the applicant has one or more felony convictions that have not previously been disclosed to the Board and has not received an absolute discharge from the sentences for all felony convictions three or more years prior to the date of filing an application. If this information applies to you, your application will not be processed, and denial of your application will be instituted by the Board of Nursing.

## **ADVISING**

## **ADMISSIONS**

Enrollment is limited and the selective admission process is highly competitive. The number of students admitted shall be determined by the number of qualified faculty, the size, number and availability of educational facilities and resources, the availability of the appropriate clinical learning experiences for students, and any grant requirements. Students must meet the minimum admission requirements of the program and those required for admission to Yavapai College. Admission to the program is based on a point value system. Points are calculated by a formula related to the ATI TEAS pre-entrance exam and residency, as listed on the Yavapai College Practical Nursing Fast Track Program Selection Criteria form. All pre-entry requirements **must** be completed and submitted with the application **prior** to receiving credit for points towards acceptance into the Fast Track Practical Nursing Program.

## **PROGRESSIONS**

To qualify for enrollment in subsequent requisite, pre-requisite, and co-requisite courses, the following must be achieved:

- a) Pass all components of the current practical nursing courses.

- b) Maintain compliance with the Health and Safety requirements of the Practical Nursing Fast Track Program throughout the semester of enrollment until program completion.
- c) Meet all deadlines for clinical facility requirements (ie: mCE, CastleBranch) by the due dates.
- d) Maintain and demonstrate professional student conduct at all times when in the Fast Track Practical Nursing Program as described in the Fast Track Practical Nursing Program Student Handbook and Yavapai College [YC Code of Conduct](#).

### **PROGRAM SELECTION CRITERIA**

Admission to the program is based on a 600-point system, utilizing the criteria listed below. Students will be required to provide proof of residency (tuition residency is defined by the Arizona State Legislature and is outlined in the Yavapai College catalog). Final selection and placement will be determined by the Allied Health Program Director.

### **SELECTION CRITERIA SCORING**

An application must be complete for the applicant to be considered for final selection and placement. Proof of attendance at a Pre-Practical Nursing Workshop within the last 12 months of application submission is required. Applicants are ranked using the Yavapai College Fast Track Practical Nursing Program Selection Criteria.

**Prescott Valley Center placement:** The 20 highest ranked applicants will be offered seats, based on space availability. The next 5 applicants on the ranking will be offered alternate status.

When several applicants have the same ranking score, the following criteria will determine tie breakers:

1. ATI TEAS exact cumulative score
2. Date of completed application submission

All applicants will be notified via their YC scholar email after final determinations have been made. ## **HEALTH REQUIREMENTS**

### **Essential skills and functional abilities**

Certain skills and abilities are essential for the delivery of safe, effective nursing care. These are essential in the sense that they constitute core components of nursing practice, and there is a high probability that negative consequences will result for patient/clients under the care of nurses who fail to demonstrate these skills and abilities. A program preparing students for the practice of nursing must be able to attend to these essential functional abilities in the education and evaluation of its students.

This statement identifies the functional abilities deemed by the nursing faculty to be essential to the practice of nursing. Reference material used in the development of these standards include the Arizona Nurse Practice Act and The Functional Abilities Essential for the Delivery of Safe and Effective Nursing Care (a descriptive research study conducted by the National Council of State Boards of Nursing). The essential skills and functional abilities are reflected in the Practical Nursing Fast Track Program's performance-based outcomes, which are the basis for teaching and evaluating all practical nursing students.

Students with disabilities who think they may require accommodation in meeting these standards should contact the Office of Disability Resources to discuss the process of identifying reasonable accommodation. Students should seek advice regarding accommodation as soon as possible so that a plan for reasonable accommodation can be in place at the beginning of the program. Registration with Disability Resources is required before any accommodation requests can be granted. Yavapai College will provide equal educational opportunities for students with disabilities while adhering to the standards of nursing practice for all students. Under no circumstances will any course requirements or standards be waived for any student, with or without a disability. The ultimate determination regarding reasonable accommodations will be based upon preservation of patient safety.

### **HEALTH DECLARATION**

It is essential that nursing students be able to perform a variety of patient care activities without restrictions in the clinical portion of the program. At a minimum, students will be required to lift and/or reposition patients, have physical capacity sufficient to complete assigned periods of clinical practice, and perform gross and fine motor skills essential to providing safe patient care. Students will be required to transport patients on gurneys and in wheelchairs, move heavy equipment throughout the clinical site, and must be physically capable of performing CPR in an emergency. Students will encounter situations requiring them to lift and manipulate weight greater than 50 pounds. It is advisable that students consult with their physicians prior to the start of this program and determine their ability to perform the necessary job requirements. Students who have medical impairments must be capable of implementing safe, direct patient care, while maintaining their current treatment plan or medication regimen.

Clinical experiences also place students under considerable mental and emotional stress as they undertake responsibilities and duties impacting patients' lives. Students must be able to demonstrate rational and appropriate behavior under stressful conditions. Individuals should consider the mental and physical demands of the program.

A healthcare provider must sign the **Health Care Provider Signature Form** attached at the back of this document stating that these conditions can be met. The completed form is submitted upon conditional acceptance to the Fast Track Practical Nursing Program. Health care providers who qualify to sign the declaration include a licensed physician (M.D., D. O.), nurse practitioner, or a physician's assistant. Their medical license number must be ***included on the form along with date the physical examination was performed***. The physical examination date must not exceed **six months** from conditional acceptance to the Fast Track Practical Nursing Program. Please also note that a doctor's release may be required to enter or continue in the program as illness or injuries occur.

### **FINGERPRINT CLEARANCE**

The Level I Fingerprint Clearance Card is a requirement of the Nursing Program application process and must remain valid for the duration of all nursing courses. Federal law and agency accreditation rules require a DPS Fingerprint Clearance Card for nursing students. Please visit <https://www.azdps.gov/services/public/fingerprint> to determine how to obtain or renew an Arizona DPS Level I Fingerprint Clearance Card.

Fingerprint processing services are available through a third-party vendor contracted with AZDPS. Students may access the online application through the website above and may need to contact the fingerprinting location by phone to process their fingerprint application for AZDPS.

Applicants should check for an available fingerprinting location site and verify hours of operation prior to registration. Online registration is required on the DPS website before scheduling and processing payment for the fingerprint location. Applicants must bring their registration number along with a government issued photo id, and a secondary form of identification (as needed) to the location site. Processing may take 1-4 weeks from the date Arizona DPS receives the completed application packet. For those individuals who do have a criminal record, the process may take 6 -13 weeks.

A copy of the front and back of the student's current Arizona Level I Fingerprint Clearance Card is required as part of the initial application submission for the Nursing Program and is kept as part of the student file. A full copy of the card is included in CastleBranch as a compliance document. The student is responsible for completing this Castle Branch requirement upon conditional acceptance to the program, and for submitting renewal documentation prior to the card expiration date as needed.

If there is a positive criminal history, the Level I Fingerprint Clearance may be denied which will result in removal from the Nursing Program.

A student whose conduct results in the loss of fingerprint clearance will be dropped from the Nursing Program and will not be allowed to progress until a Level I Fingerprint Clearance Card is obtained. If the time-period for clearance progresses past one year of removal from the Nursing Program, the student will need to re-apply to the Nursing Program and repeat any courses already taken.

### **ATI TEAS PRE-ADMISSION TESTING**

Applicants seeking admission to the Fast Track Practical Nursing Program must complete ATI TEAS pre-admission testing through Yavapai College Testing Services and submit the test results with their application. Test results are good for two consecutive application cycles (current and last application cycle). Applicants who take the ATI TEAS within the current and last consecutive application cycle may submit the report with the highest cumulative score.

The ATI TEAS cumulative report results are to include student name, testing location, the cumulative score, and scores from each of the following categories: Reading, English and Language usage, Math, and Science. A minimum cumulative score of 55.4% is required for application submission. A student is allowed one retake during the application cycle, with provided proof of remediation between exams. *Failure to provide complete score data will result in an incomplete application.*

Registration for the Practical Nursing Fast Track Program pre-admission testing is completed through the Yavapai College Testing Services website at [www.yc.edu/tesing](http://www.yc.edu/tesing). The payment receipt or order confirmation number is needed to schedule an ATI TEAS test date appointment. Both the payment and appointment must be completed within the semi-annual registration period listed on the Testing Services website.

### **APPLY FOR ADMISSION**

Students must apply to and be admitted to Yavapai College if not currently enrolled as a student, prior to applying to the Fast Track Practical Nursing Program. Please go to [www.yc.edu](http://www.yc.edu) and complete the Yavapai College admission procedure.

Practical Nursing Program applications will be accepted from **August 4<sup>th</sup> through September 30<sup>th</sup>, 2025**, for Spring 2026 acceptance. Applications must be submitted electronically via the Secure Upload link on the Yavapai College Allied Health website at [www.yc.edu/alliedhealth](http://www.yc.edu/alliedhealth).

Please note: Images/photos of documents that are converted to PDF can create larger file types which may cause accessibility issues when combined and emailed. In this instance, hard copies of documents may be scanned and combined into one PDF packet prior to submission.


All required documentation must be submitted with the application by the due date deadline. Incomplete applications will not be considered for review. **There are no exceptions.**

Application forms and copies of all required documentation should be submitted as one PDF packet. The packet label must include student name (last name – first name) and Y Number.

**Example: (Last Name-First Name- Y#) Nightingale-Flor-Y0123450**

#### **ADDITIONAL ADMISSION REQUIREMENTS AFTER CONDITIONAL ACCEPTANCE**

1. Drug testing, Criminal Background Check, and Immunization Tracker (One all-inclusive package through Castle Branch): a fee of \$151.00 is payable to CastleBranch after a conditional acceptance letter is received. An additional fee may be required if you have had multiple addresses in past years. Payment for Castle Branch accounts must be completed in a timely manner to allow adequate time for background check processing and program compliance.
2. The completed Health Care Provider Signature Form (Appendix A) submitted to Castle Branch as part of the Immunization Tracker documentation.
3. Yavapai College Picture ID – due the first day of classes - email **onecard@yc.edu** to obtain a physical ID card. Refer to: <https://www.yc.edu/v6/enrollment-services/onecard.html> for more information.
4. Some clinical site affiliates no longer accept Drivers Licenses or state-issued ID cards that are not **REAL ID** compliant. Students must have 2 separate forms of IDs.
  - Primary ID: **REAL ID** (has the Star  Symbol), active Passport, or military/military dependent IDs only.
  - Secondary ID: SSN Card, birth certificate, certificate of naturalization, voter registration card or tribal card.

#### **DRUG TESTING**

Random drug testing is a standard procedure throughout the Practical Nursing Program. The first drug test will be at the student's expense. Any subsequent drug testing will be done at the program's expense. When a student is informed that they are a subject of random drug testing, they will be provided an appropriate form and a list of local laboratories that they can utilize. The drug testing must be completed by the end of that business day.

#### **BACKGROUND CHECK**

All students are required to obtain a background check. Information regarding how to obtain the background check will be provided to the student upon provisional acceptance to the program. The cost of this background check is at the student's expense. Due to clinical agency contracts, any negative results will be reviewed to determine admission or continuation in the program, on a case-by-case basis by the Nursing Department and the Allied Health Program Director.

#### **IMMUNIZATIONS**

Immunizations are required by clinical agencies with which Yavapai College has an affiliation. Yavapai College has no control over a clinical agency's health standards and requirements for students participating in clinical learning experiences. Clinical learning experiences in

facilities/agencies is a requirement of the Fast Track Practical Nursing program for all practical nursing students. All student clinical placements are final.

Students are responsible for remaining in compliance with all mandated immunizations and must adhere to all deadline requirements. Copies of immunization records and updated immunization documentation must be submitted to CastleBranch (castlebranch.com) after admission to the Fast Track Practical Nursing Program for the student files as required by the Department to remain and continue in the program.

Students who have upcoming expirations for immunizations or documentation that will occur during the first semester must renew the requirement prior to program start. It may be necessary to contact CastleBranch to request a re-set to the expiration date to upload renewal documentation.

As part of our affiliation agreements with healthcare institutions, Yavapai College is required to provide healthcare facilities/agencies with pertinent healthcare documentation upon their request and would obtain the documentation from CastleBranch and/or My Clinical Exchange.

Students registering for courses or programs with clinical requirements may not be able to complete the course/program without proof immunizations and/or regular health screenings and testing as determined by the healthcare facility/agency.

All immunization records must include your name, date, and name and signature of healthcare provider giving the immunization.

1. **MMR (Measles, Mumps, and Rubella):** Adults entering health care professions must have documented proof of immunity (**positive titer**) or **proof of two MMR's**. A positive titer needs to be positive for Measles, Mumps, and Rubella. Additional immunization is generally required when titer results are not positive for each- plan accordingly. Persons born prior to 1957 may be considered immune.
2. **Varicella (Chicken Pox):** Documented proof of immunity or two varicella immunizations are required upon conditional acceptance of the student into the Fast Track Practical Nursing Program. If the student has had chickenpox, a positive titer is necessary to document immunity.
3. **Hepatitis B:** Documented evidence of completed three-dose series or positive titer. Complete documentation is submitted to CastleBranch upon conditional acceptance to the Program. *If beginning a series, allow for six months prior to application submission for completion.*
4. **Tdap (Tetanus, Diphtheria and Pertussis):** A vaccination is required every ten (10) years. It is the responsibility of the student to maintain a record of a Tdap vaccination of less than ten (10) years throughout the duration of the Fast Track Practical Nursing Program.
5. **Influenza:** Annual vaccination is required. It is the responsibility of the student to receive

an annual vaccination and have proof submitted to CastleBranch by October 1<sup>st</sup>, or prior to clinical commencing for new incoming students beginning in a fall term. Students who begin the Fast Track Practical Nursing program in spring, should already have the current flu season immunization completed upon conditional acceptance to the program. If allowed for and provided for by the clinical agency, you may submit a waiver for medical reasons signed by a healthcare physician/provider or a religious exemption per the clinical agency policies and requirements.

**6. COVID-19 Vaccine:  
(Site Dependent)**

One of the following **may** be required:

- a. Documentation of your COVID-19 vaccination(s). If you receive the 2-dose vaccine series, both doses must be submitted at the same time for approval. Documentation must include the vaccine manufacturer and date.

Please note you are not considered fully vaccinated until 2 weeks after the second dose of the Pfizer-BioNTech or Moderna COVID-19 vaccine, or 2 weeks after a single dose of Johnson & Johnson's Janssen COVID-19 Vaccine.

- b. If allowed for and provided for by the clinical agency, you may submit a waiver for medical reasons signed by a healthcare physician/provider, or a religious exemption per the clinical agency policies and requirements.

Covid Booster: Documentation may be submitted to Castle Branch once immunization is received.

*\*Please be aware that for a clinical agency to accept students, the student must meet all requirements of the clinical agency. The requirements include providing proof of full vaccination against COVID-19. You should understand that as a student if you are not fully vaccinated by the time clinical begins, and/or the site does not accept a vaccination exemption, you will not successfully complete the required clinical hours and will not be able to progress in the program.*

Students participating at a healthcare institution licensed under A.R.S. Title 36 which includes hospitals, nursing care institutions, residential care institutions, intermediate care facilities for individuals with intellectual disabilities (ICF-IID), group homes, or other medical facilities may be required to provide proof of COVID-19 vaccination and subject to regular health screening and testing as determined by the healthcare institutions.

It is important to understand that while Yavapai College does not require or mandate COVID-19 vaccinations or testing, our healthcare facility/agency partners have the right to do so and are the decision makers on whether a student will be allowed to take part in clinical learning placements at their facility/agency.

7. **Tuberculosis: Incoming students** must provide one of the following: an initial 2 step TB Skin Test, or a T-spot or QuantiFERON Gold Blood test. If results are positive, a chest x-ray with an annual statement signed by a health professional that student does not have active tuberculosis must be provided. A one step TB Skin Test will be acceptable for renewal documentation only.

**TB Renewal:** Negative skin test or blood test (annually) or chest x-ray (valid for two years) with an annual statement signed by a health professional that student does not have active tuberculosis. It is the responsibility of the student to maintain annual screenings. Documentation is to be renewed prior to semester start if the expiration date occurs while a semester is in progress.

### **CARDIOPULMONARY RESUSCITATION (CPR) CERTIFICATION REQUIREMENT**

BLS (Basic Life Support) certification for Health Care Providers must be current for the entire Nursing Program. CPR certification status is reported annually while students are enrolled in the program. The Fast Track Practical Nursing Program will only accept BLS Provider certification (CPR & AED) through American Heart Association (AHA). An in-person course or a course with an in-person check-off is required. A student without current documented BLS Provider certification (CPR & AED) will be dismissed from their clinical rotation and/or the Nursing Program. It is the responsibility of the student to maintain current certification and submit renewal documentation to Castle Branch according to Fast Track Practical Nursing Program guidelines. Documentation is to be renewed prior to semester start if the expiration date occurs while a semester is in progress.

For program compliance, students are responsible for keeping their fingerprint clearance, CPR, and health care requirement documentation current through the entire duration of the Fast Track Practical Nursing Program enrollment and/or graduation. To remain in the Fast Track Practical Nursing Program theory and clinical courses, all required documentation needs to be entered and current in CastleBranch in addition to being approved by the clinical agency, clinical coordinator and/or course instructor two weeks prior to the start date. If the student is not compliant with these policies, the student will not be able to attend clinical and will be administratively withdrawn from their current nursing course(s) by the Director of Allied Health.

Incoming students are required to meet the program compliance dates provided in the Fast Track Practical Nursing Program acceptance packet. If a student does not meet the deadlines as identified on the forms provided in the acceptance packet, the student's program acceptance will be administratively withdrawn by the Director of Allied Health.

### **NOTIFICATION OF ACCEPTANCE**

Letters of Acceptance will be sent to the YC scholar email account within four weeks of the application deadline. *If an applicant does **not** have a scholar email account, the letter will be sent by postal mail to the mailing address provided by the applicant on the Application for Admission.* **Please refrain from contacting the Allied Health Department if you have not received a letter within 30 days of the deadline date.** It is your responsibility to make sure that your scholar email account and mailing address are current, and up to date with the department always. You can do this by emailing [kelsey.mccasland@yc.edu](mailto:kelsey.mccasland@yc.edu) with your new address or phone number AND

changing contact information in your myYC portal account so that it may be verified.

If you are not accepted to the program, you will receive an email stating so. Alternates are also identified at this time and notified. Notification is made to the YC scholar email account. Students will be required to transport patients on gurneys and in wheelchairs, move heavy equipment throughout the clinical site, and must be physically capable of performing CPR in an emergency. Students will encounter situations requiring them to lift and manipulate weight greater than 50 pounds. It is advisable that students consult with their physicians prior to the start of this program and determine their ability to perform the necessary job requirements.
